TO PARENTS OF STUDENTS ATTENDING Mid Valley Academy:

Under the No Child Left Behind (NCLB) Act of 2001, a Title I, Part A-funded local education agency (LEA), or school district, that has not met AYP for two or more consecutive years in the same indicator (reading, mathematics, attendance rate, or graduation rate) is subject to LEA-level Title I School Improvement Requirements. Based on the 2010 LEA AYP Status released August 5, 2010, Mid Valley Academy is subject to the LEA-level School Improvement Program (SIP) requirements for Stage 3-Mathematics for the during the 2010-2011 school year.

The NCLB statute requires the district to notify you of this status and to provide you with the following information. Please be advised that the district has the opportunity to appeal this district improvement designation. However, the requirements described in this letter must be implemented for the entire school year, regardless of the outcome of the appeal.

Within three months after being identified for improvement, an LEA must develop or revise its district improvement plan in consultation with parents, school staff, and others. The district improvement plan must meet certain requirements, one of which is implementing strategies to promote effective parental involvement in the district. The district will be implementing the following activities to address the reasons the district has been identified for district improvement: will deliver an effective, consistent & rigorous TEKS-based curriculum; continuously use student data to monitor achievement; increase and strengthen contact among parents and instructional staff and school leadership; improve school climate to provide a safe environment conducive for learning; implement an 'optional flexible school day program' model to assist with student retention and graduation. Additionally, an early warning dropout prevention system will be identified by implementing a coordinated program of social services and community outreach to meet student needs. The district will also assist campus staff in analyzing test, attendance and leaver data as well as assist the campuses in increasing meaningful parental involvement activities.

You may become involved in addressing the reasons the district is identified for improvement by assisting in the following ways: assist the district/campus staff in reviewing and revising the CIP; participate in parent involvement activities that assist you in learning how to increase your child's achievement level; and attend parent-teacher conferences.
